In that event, this form of proxy will be deemed to have been revoked.
- To be valid, this form of proxy and, if such proxy is signed by a person on behalf of the appointer pursuant to a power of attorney or other authority, a notarially certified copy of that power of attorney or other authority must be delivered to the head office of the Company in the PRC at No. 6 Wenxuan Road, Shang Mao Dadao, Cheng Bei, Chengdu, Sichuan 610081, the PRC not less than 24 hours before the time appointed for the holding of the Domestic Shares Class Meeting (or any adjournment thereof) or not less than 24 hours before the time appointed for taking the poll.
- In the case of joint holders of Domestic Shares of the Company, any one of such holders may vote at the Domestic Shares Class Meeting either in person or by proxy in respect of such shares as if he/she was solely entitled thereto. However, if more than one of such joint holders are present at the Domestic Shares Class Meeting in person or by proxy, then one of such holders whose name stands first in the register of members of the Company shall alone be entitled to vote. In the event that a shareholder appoints more than one proxy to attend the Domestic Shares Class Meeting, such proxies may only exercise their voting rights in a poll.
